

# Town of Angelica Board of Review

May 20, 2020

The first session of Board of Review for the Town of Angelica was held at 6:00 p.m., May 20, 2020. Town Chairman, Richard Ferfecki, called the May 20, 2020 session of Board of Review to order at 6:00 p.m. Present as Board of Review members were Richard Ferfecki, James Przybylski, Greg Van Asten and Connie Przybylski. Paul Denor, from Fair Market Assessments Inc. the assessing firm for the Town of Angelica, was also present. The chairman verified with the Clerk that proper notice of the Board of Review had been done. The full first notice of Board of Review was published in the Shawano Leader on April 24, 2020, put on the town's website, posted at the town hall, and at the Krakow post office.
