

Town of Angelica Board of Review

May 23, 2023

The first session of Board of Review for the Town of Angelica was held at 6:00 p.m., May 23, 2023. Town Chair, James Przybylski, called the May 23, 2023 session of Board of Review to order at 6:00 p.m. Present as Board of Review members were James Przybylski, Greg Van Asten, Brian Eckberg and Connie Przybylski. Paul Denor, from Fair Market Assessments Inc. the assessing firm for the Town of Angelica, was also present. The Clerk verified that proper notice of the Board of Review had been done. The full first notice of Board of Review was put on the town's website, posted at the town hall, at the Krakow post office on April 24, 2023. Also posted agenda on May 22, 2023 on the town's website and at the town hall.

Greg Van Asten had a question about a parcel he owns, but no formal objection form was filed.
