April 8, 2024

**Call to Order/Pledge of Allegiance/Roll Call/Verification of Meeting Notice:** Chairperson Przybylski called the meeting to order at 6:30 p.m. Roll call resulted in all town officials being shown as present. The Clerk verified that the agenda was posted at the town hall, on the town's website, e-mailed to the Shawano Leader, on Wednesday, April 3, 2024. *MOTION (Van Asten/ Eckberg/PASSED UNANIMOUSLY) to allow modification of the agenda if necessary.*

**Approval of Prior Town Board Minutes:** *MOTION (Van Asten/Eckberg/PASSED UNANIMOUSLY) to approve the minutes of the regular board meeting held on March 11, 2024.*

**Approval of Treasurer's Monthly Report:** The Treasurer's report was read by Treasurer Matuszak showing balances as of March 31, 2024, of \$15,916.71 in the Premier Checking Account, \$421,641.38 in the Premier Bank Advantage Tax Account and \$515,188.48 in the CoVantage ATC Account, \$14,548.33 in the Fox Community Credit CD, \$361.89 in the CoVantage Angelica Community Park Donations Account, \$4,248.74 in the CoVantage ATC Savings Account, and \$5 in the Fox Community Credit Member Share Account. *MOTION (Eckberg/Van Asten/PASSED UNANIMOUSLY) to approve the Treasurer's report as presented. Brian Eckberg asked a question about the ARPA funds.*

**Correspondence & Clerk's Report:** Clerk Przybylski presented correspondence received which consisted of (1) nine fire incident reports from the Pulaski Tri County Fire department (2) Fire inspection report for the town hall (3) four land use permits, one for a single-family dwelling, three for accessory residential structures (4) Bonduel EMS monthly report for March. Clerk Przybylski also presented the Spring Election results from April 2, 2024.

**Reports from Town Officers:** Supervisor Van Asten reported that (1) installed a 911 fire number on Paloma Court (2) removed a downed tree on Park Street. Supervisor Eckberg had no report.

**Town Chairman:** Chairperson Przybylski reported that he attended the NEW Rescue meeting on March 25. There were four ambulance runs for January and six runs for February and the average response time was 7.21 minutes. The total ambulance runs for all towns were 111 for 2024. Chair Przybylski reported that he attended the Tri County Fire Department on March 26, 2024. There were seven fire calls for Angelica with a total of 40 calls for all towns. The Fire Department has 35 active members with one more possible member. They received a DNR grant which they can use for pagers, radios, and small equipment. The fire department did a walk through at the new Riesterer & Schnell to check their setup.

Chairperson Przybylski received a call from a good Samaritan about three five-gallon pails that were dumped in the ditch on Middle Drive. I picked them up and they were filled with waste oil and found a tire in the ditch on Maple Road. Chairperson Przybylski reported on winter storm Cora, there were downed trees on Angelica Street and Nichols Road. He called M & L Excavating to remove and plow town hall parking lot for election access. Chair Przybylski called Shawano County hotline to have trees removed on County Road C north of the town hall. Shawano County starting plowing at 8 pm and McKeefry went out at 1 am. McKeefry & Sons had to send out an extra plow truck to help plowing due to a power line that fell on a truck on Hoff Street. Town roads were plowed by 9 am and power was out in a lot of the town due to trees and bent power poles with wires touching. Chair Przybylski attended the State Highway 117 construction project informational meeting in Bonduel and I have information if anyone want to check out what is happening. Chair Przybylski reported that the brush/tree removal on Cuba Drive is complete and the trees, brush, and ditching on Maple Road is complete. Chair Przybylski attended the WTA Board of Review training, took the test, and signed and gave to the clerk to file. Open Book will be Tuesday, May 14 starting at 1 pm and Board of Review will be on Wednesday, May 22 at 6 pm.

**Shawano County Board Supervisor ~ District 11:** James Przybylski reported that the county is looking at options for the courthouse and jail facilities, they also toured Waushara Counties new facilities for ideas.

**Public Comments:** There were twenty residents that spoke out on the public nuisance ordinance that was on the agenda. Comments included not to support it, seems to harsh, seems like a city ordinance not a town ordinance, should be a committee in charge not the town board. Kevin Wegner asked about the snow plow gouging out the grass on the corners and can I fix my lawn. Robert Kuczer stated the weight limit signs should say "off." Chair Przybylski stated he has the off stickers and did not get them put on yet. Two residents asked about the agenda and minutes being posted and where to find them. Chair stated the agenda was posted on April 3 on the town website and on the posting board at the town hall, and the minutes are also posted on the website too.

#### **Matters for Discussion and Possible Action by Town Board Open Session:**

- a. *MOTION (Eckberg/Van Asten/PASSED UNANIMOUSLY)* to approve the ditch maintenance on Deer Drive. Jason Bergner has hired a bonded contractor that will be working with adjacent land owners and doing the ditch maintenance.
- b. Discussion took place and the Public Nuisance Ordinance. Chair Przybylski supports this draft ordinance, Supervisor Van Asten and Supervisor Eckberg do not support. *MOTION (Eckberg/Van Asten/PASSED)* to place the ordinance on file for up to one year.
- c. Discussion took place on the chair duties. The Chair position was given these duties over the past twenty-four years according to the past minutes. WTA recommended putting the duties in a resolution for ease of access. *MOTION (Van Asten/Eckberg/PASSED UNANIMOUSLY)* to approve Resolution 4-8-24 Chair Duties.
- d. Discussion took place on crack sealing of roads. Chair Przybylski gave a list of roads that were suggested by Crack Filling Service. These roads include South Town Line, Carroll Road, Beech Drive, Cedar Road, Mile Drive, Cherry Drive. The Supervisors asked for estimates for next months meeting.
- e. Discussion took place on No Thru Trucks on town roads for long trucks. Chair Przybylski gave a map of the state designated truck routes that the trucks should follow. There was a consensus of the board for the Chair to get more information from the state.

- f. Discussion took place on the annual meeting which will be held on April 16, 2024 at 7 pm located at the Angelica Town Hall at N3285 County Road C.
- g. Discussion took place on installing a mail box at the town hall. *MOTION (Van Asten/Przybylski/PASSED UNANIMOUSLY)* to approve getting a mail box for the town hall.
- h. Discussion took place on where the donated park equipment should be installed at the Angelica Community Park in Krakow. Chair Przybylski suggested putting it on the unused volley ball court and bring one swing set and slide to the town hall. *MOTION (Eckberg/Van Asten/PASSED UNANIMOUSLY)* to approve putting the equipment on the sand area of the volley ball court and bring some pieces to the town hall.

**Specific Town Board Notice and Agenda for Upcoming Town Board Meeting:** Crack sealing, No Thru trucks. The next town board meeting will be held on Monday, May 13, 2024.

**Voucher Listing/Payment of Bills:** *MOTION (Van Asten/Eckberg/PASSED UNANIMOUSLY)* to approve Vouchers V-10606 through V-10635 for a total of \$68,273.00.
