June 3, 2015

Town of Angelica Committee Present: Chairman Richard Ferfecki, Secretary Connie Nischke, Dwayne Splan.

The meeting of the Angelica Planning Committee was called to order at 7:00 p.m. The Pledge of Allegiance was said.

Tom Maroszek was present to ask for a five year renewal for the conditional use permit for the Wolak Sand Pit on Elm Road in Pulaski (CU-24-00). Parcel #004-03090-0000. The committee reviewed every condition on his current permit and decided everything should remain the same in addition to two new conditions — (11) Slope on sand pile not to exceed a 3 to 1 pitch and (12) Certificate of insurance needed for any private haulers using pit. No one was present to oppose the request.

Dwayne Splan made a motion to extend the renewal for the 5 years for the sand pit operation (CU-24-00). Connie Nischke seconded the motion. The motion carried unanimously.

A Motion was made by Nischke and seconded by Splan to adjorn the meeting. The motion passed unanimously at 7:25 p.m. The next meeting will be July 7, 2015, unless no action is necessary.

Conditions for CU-24-00 (Tom Maroszek – Wolak Sand Pit Operation)

- 1. The excavation of sand from the property to be as indicated on the drawings/aerial photos and letter dated 5-22-00 for Performance Excavating.
- 2. The driveway remains graveled.
- 3. Land reclaimation plan followed from East Central Planning (Topsoil replaced, etc.). The plan must address the issue of the land so it can be used again for agricultural purposes.
- 4. Hours of pit operation will be 7:00 a.m. to 6:00 p.m. Monday thru Friday and 7:00 a.m. to 12:00 p.m. on Saturday.
- 5. Trucks delivering sand from this pit will not go through the Village of Krakow to access State Hwy. 32 except in cases where the sand would be delivered to a property owner in Krakow.
- 6. The sand excavation/removal operation is to be conducted in such a manner so as to avoid any damage or nuisance affect to adjacent property and/or structures.
- 7. This permit will expire in 5 years at which time applicant may appear before the committee to request a 5 year extension.
- 8. The committee may, at any time, amend or add conditions to this permit approval to ensure compliance with all legal requirements.
- 9. A bond of \$5,000 shall be put up to help cover road repair in the future per Town Ordinance 511-09 (page 31, paragraph 3 on the Town of Angelica Comprehensive Plan).
- 10. Original permit that was granted to Performance Excavating must be transferred to Tom Maroszek.
- 11. Slope of pit not to exceed 3 to 1 pitch.
- 12. Certificate of Insurance needed for any private haulers using pit.

^{**} The operator gives the Town of Angelica permission to spot check at any time for compliance with the requirement for silt screening in the quarry.
