Public Hearing

Richard Ferfecki, Chairman of the Planning Committee opened the hearing at 7:05 p.m. The Pledge of Allegiance was said. He verified with the Committee Secretary that the public hearing had been posted, introduced planning committee members and explained the procedure.

Request #1: CU-2-16 Craig and Dawn Sampo were present to request a conditional use permit to construct two fish ponds for aquaponics/aquaculture at N3749 State Highway 32, Pulaski

Legal Description: #004-13440-0000. SE ¼ SE ¼ except North 129' of South 258' of East 208' and except South 113' of East 208' and except West 330' of East 535.7' of South 264' and except certified survey map recorded in Volume 9, page 289 Section 13, T26N, R18E. Town of Angelica, Shawano County, Wisconsin. 34.658 acres.

Craig and Dawn Sampo were present to request a conditional use permit to construct two fish ponds for aquaponics/aquaculture which is an agricultural use and is permitted use by Shawano County Zoning at N3749 State Highway 32, Pulaski in the Town of Angelica. There would be two ponds dug each being 1/3 to ½ acre in size. They plan on stocking the ponds with perch and each winter, one of the ponds will be down. The waste and waste water from the fish will be used as organic plant food. It was recommended that borings be done to see if overflowing will be a problem. This should be done before the project begins. Most guidelines set by the Town of Angelica will be followed except for #2 that there will be no bottom slope of not greater than 1 foot of fall in 5 feet of travel for the first 10 feet and 3 to 1 thereafter because the ponds are for fish. A 18" berm should be constructed where there will be an actual shoreline on the one side. Fish ponds should have a steeper shoreline to help control predators and weeds. The town should also require a fence be put around both ponds along with signs on the fence indicating deep water. A county land use permit will be required. Liability insurance will also be required. No one was present to oppose of the request.

Town of Angelica Planning Committee Meeting

The meeting of the Planning Committee was called to order immediately following the Public Hearing by Chairman Richard Ferfecki. The Committee verified with the Secretary of the Committee that the notice of the meeting and agenda had been posted properly.

A motion was made by VanDonsel and seconded by Ferfecki to approve June 7, 2016 minutes. The motion passed unanimously.

A motion was made by VanDonsel and seconded by Nischke to approve request CU-2-16 for Craig and Dawn Sampo to construct fish ponds. The motion passed unanimously.

A motion was made by Nischke and seconded by VanDonsel to adjourn the meeting. The motion passed unanimously at 8:00 p.m. The next meeting will be September 6, 2016 unless no action is needed.
