The proposed tax levy of \$468,905.00 for 2025 taxes was arrived at by using a mil rate of \$2.50421504 per thousand. The Statement of Assessment for the Town of Angelica showed an Aggregate Assessed Valuation of \$187,246,300. The levy is within the State of Wisconsin tax levy limit.
