

**Budget Hearing for Proposed 2024 Town of Angelica Budget
November 13, 2023**

The Budget Hearing was opened at 6:00 p.m. by Town Chair, James Przybylski. *[Clerk's Note: Posting of the Budget Summary and Notice of Public Budget Hearing was done on October 25, 2023 at the town hall, Krakow Post Office and also put on the town's website.]* A copy of the proposed 2024 budget was available to all those in attendance.

The Chair opened the hearing and went over the proposed budget and then asked if there were questions from those present.

The proposed tax levy of \$452,838.00 for 2023 taxes was arrived at by using a mil rate of \$2.507878 per thousand. The Statement of Assessment for the Town of Angelica showed an Aggregate Assessed Valuation of \$180,566,200. The levy is within the State of Wisconsin tax levy limit.
