

**Budget Hearing for Proposed 2023 Town of Angelica Budget

The Budget Hearing was opened at 6:00 p.m. by Town Chairman, Richard Kucksdorf. *[Clerk's Note: Posting of the Budget Summary and Notice of Public Budget Hearing was done on October 28, 2022 at the town hall, Krakow Post Office and also put on the town's website.]* A copy of the proposed 2023 budget was available to all those in attendance.

The Chairman opened the hearing with a power point presentation and then asked if there were questions from those present.

The proposed tax levy of \$441,834.00 for 2022 taxes was arrived at by using a mil rate of \$2.478801649 per thousand. The Statement of Assessment for the Town of Angelica showed an Aggregate Assessed Valuation of \$178,245,000. The levy is within the State of Wisconsin tax levy limit.
